Terms of Agreement for Pet Care Services

PET CARE:

1) I, _____ (Client) authorize West Coast Pets, LLC to perform pet care services as outlined in Client Profile, Pet Profiles, and Service Policies, which shall become part of this contract.

2) If a pet becomes ill while under the care of West Coast Pets, LLC, I authorize their representative to transport my pet to my veterinarian, or one who is available, if deemed necessary in his/her best judgment. I authorize said representative to approve any emergency treatment recommended by the veterinarian (unless otherwise stated in Veterinarian Release Form) and I agree to pay promptly for any charges incurred. I release WCP, LLC from any and all liabilities related to transportation, treatment, and expense.

3) I agree to reimburse West Coast Pets, LLC for any additional fees for tending to emergency or veterinary care. Client also agrees to reimburse WCP, LLC for additional time accrued at the rate of \$25.00 per hour in the case of such an emergency.

LIABILITY:

1) Client expressly waives and relinquishes any and all claims against West Coast Pets, LLC, its employees, and associates, except those proven to be arising from negligence on the part of WCP, LLC.

2) West Coast Pets, LLC, company owner, agents, assigns, successors and heirs are not liable and are completely indemnified for any and all liability stemming from the act(s) or failure to act of third parties, whether known or unknown,

including, but not limited to, friends, neighbors, relatives or other service persons that shall enter your home for any purpose while we are caring for your pets. On Page 2 of your Client Profile, list the names and phone numbers of persons with your permission to access your home during this service period. If upon arrival for pet care services we encounter a person in your home that is not on your list, we will immediately leave and contact you for conformation that the person is not an intruder.

3) It is expressly understood and agreed that West Coast Pets, LLC shall not be held responsible for any damage to Client's property, or that of others, caused by Client's pet(s) during the service period.

4) I also agree that it is my responsibility to notify WCP, LLC if any of my pets have ever caused injury to any person, or animal. If a pet has a history of biting or other aggressive behavior, West Coast Pets, LLC reserves the right to refuse service. Bites must be reported to the local authorities as provided by law. The owner will be liable for medical expenses and damages that result from a bite.

5) I attest to the fact that all licenses and vaccinations required by the State of Washington, and City in which I reside and/or the County of Whatcom are current according to law. _____ (initial here)
